force the BlackBerry® device to synchronize the status of the RIM DST 2007 patch back to the BlackBerry® Enterprise Server	<p>Previously, the BlackBerry device reported to the BlackBerry Enterprise Server that it was in an Error state when in fact the RIM Daylight Saving Time (DST) 2007 patch had been applied successfully. You can now use the -invokesync parameter with the DST 2007 Query tool to force the BlackBerry device to synchronize the status of the RIM DST 2007 patch to the BlackBerry Enterprise Server. (SDR 122596)</p> <p>To run the DST 2007 Query tool with the -invokesync parameter, perform the following steps:</p> <ol style="list-style-type: none"> 1. Run the DST2007Query.exe. 2. Check for BlackBerry devices that report the Awaiting Patch state or Error state (DST 2007 Query tool Version 4.1.2.8 checks for the Awaiting Patch status only). 3. If the DST 2007 Query tool reports BlackBerry devices in the Awaiting Patch state or Error state, after business hours, run the DST 2007 Query tool with the -invokesync parameter. 4. In the Microsoft® Windows® Services, restart the BlackBerry Synchronization Service. 5. When the DST data has synchronized from the BlackBerry device to the BlackBerry Enterprise Server, run the DST 2007 Query tool again and repeat steps 1 through 2. It might take several hours for the DST data to synchronize.

Issue	Description
Fixed issues in DST 2007 Query tool Version 4.1.2.12	
SDR 122405	<p>Previously, the DST 2007 Query tool did not indicate that you must restart the BlackBerry Synchronization Service after you ran the DST 2007 Query tool using the <code>-invokesync</code> parameter.</p> <p>In DST 2007 Query tool Version 4.1.2.12, after you run the tool, a message appears indicating that you must restart the BlackBerry Synchronization Service.</p>
SDR 110548	<p>Previously, the DST 2007 Query tool reported that the RIM DST 2007 patch was in the Helper not installed state. The DST 2007 Query tool might not have detected from the BlackBerry Configuration Database whether the RIM DST 2007 patch was installed on a BlackBerry device. The DST 2007 Query tool located the RIM DST 2007 patch state information for that BlackBerry device, which implied that the RIM DST 2007 patch was installed at some point.</p> <p>In DST 2007 Query tool Version 4.1.2.12, the patch status state for the user account is reported as Awaiting Patch if the RIM DST 2007 patch was not yet applied for this scenario.</p>
Fixed issue in DST 2007 Query tool Version 4.1.2.8	
SDR 120331	In DST 2007 Query tool Version 4.1.2.6, if you ran the DST 2007 Query tool on a BlackBerry device that was running BlackBerry Device Software Versions 4.1.0.375, 4.1.0.377, or 4.1.0.378, the DST 2007 Query tool did not report that the BlackBerry device did not require the RIM DST 2007 patch.

SDR 122405	In DST 2007 Query tool Version 4.1.2.6, if you use the <code>-invokesync</code> parameter when you run the DST 2007 Query tool, you must restart the BlackBerry Synchronization Service.
