

BLACKBERRY TRAVEL ADDENDUM

Research In Motion Limited or one of its affiliates ("RIM") is pleased to make available to you individually, or if you are authorized to acquire the Client Software (as defined below) on behalf of your company or another entity, then the entity for whose benefit you act (in either case, "You"), the BlackBerry Travel software (the "Client Software") which facilitates using certain Handheld Products to access, subscribe to and use the BlackBerry Travel Service (together with the Client Software, "BlackBerry Travel").

BlackBerry Travel is comprised of BlackBerry Handheld Software and Service(s) as such terms are defined under the current version of RIM's BlackBerry Solution License Agreement (formerly known as the BlackBerry Software License Agreement) ("BBSLA") for Your jurisdiction and is licensed to You by RIM under the BBSLA, as supplemented and modified by this BlackBerry Travel Addendum (the "Addendum", and together with the BBSLA, the "Agreement"). If You have already agreed to the terms and conditions of the BBSLA in relation to Your use of Your BlackBerry Solution (as defined in the BBSLA), then BY CLICKING "I AGREE" WHERE PROVIDED BELOW, YOU ARE ACKNOWLEDGING THAT THOSE SAME TERMS AND CONDITIONS, TOGETHER WITH THIS ADDENDUM, AUTOMATICALLY APPLY TO YOUR USE OF BLACKBERRY TRAVEL. IF YOU HAVE NOT ALREADY AGREED TO THE BBSLA, BY CLICKING "I AGREE" WHERE PROVIDED BELOW YOU ARE AGREEING TO BE BOUND BY THE BBSLA IN RELATION TO YOUR USE OF BLACKBERRY TRAVEL AND, TO ENSURE CONSISTENT TERMS APPLY TO ALL THE SOFTWARE THAT FORMS PART OF YOUR BLACKBERRY SOLUTION, YOU ARE ALSO AGREEING THAT, AS OF THE DATE OF YOUR CLICKING "I AGREE" WHERE PROVIDED BELOW, THE BBSLA APPLIES TO ALL OTHER ASPECTS OF YOUR BLACKBERRY SOLUTION AND REPLACES AND SUPERSEDES THE PREVIOUSLY EXISTING BLACKBERRY SOFTWARE LICENSE AGREEMENTS, TO THE EXTENT SUCH AGREEMENTS ARE OTHERWISE APPLICABLE.

If You are a resident of the European Economic Area, You consent that personal information collected by RIM may be transferred outside of the European Economic Area for processing by RIM or third party service providers.
- BlackBerry Travel may collect, use and disclose Your geographic location information and travel itinerary information in order to facilitate and improve the services and functionality provided by or through BlackBerry Travel. This may involve sending Your geographic location information and travel itinerary information to third parties with products or services that facilitate the location or travel itinerary-based services You utilize through BlackBerry Travel (for example, you may choose to automatically send travel itinerary emails for inclusion in BlackBerry Travel, or if you have an eligible third party social network account you may choose to automatically post BlackBerry Travel location updates in your profile for that account). When using third party applications or services on Your BlackBerry Handheld Product that use or provide location data, you are subject to and should review such third party's terms and privacy policy regarding the use of location data by such third party applications or services.
- The location-based services of BlackBerry Travel are not intended or suitable as an emergency locator system.
