BY AGREEING TO THESE LICENSE TERMS BY CLICKING "I ACCEPT" WHERE PROVIDED BELOW, YOU INDIVIDUALLY, OR IF YOU ARE AUTHORIZED TO OBTAIN THE PROSUMER SERVICES ON BEHALF OF YOUR COMPANY OR ANOTHER ORGANIZATION, THEN THE ENTITY FOR WHOSE BENEFIT YOU ACT (IN EITHER CASE "YOU"), ARE AGREEING TO BE BOUND BY THIS AGREEMENT. PLEASE NOTE THAT YOU MUST BE OF THE AGE OF MAJORITY UNDER THE LAWS OF YOUR JURISDICTION TO ENTER INTO THIS AGREEMENT. - **Airtime Service Provider.** The BlackBerry Prosumer Services must be supported by Your Airtime Service Provider and You must have an agreement with Your Airtime Service Provider for these Services. You do not make any payment for BlackBerry Prosumer Services to RIM; all payments are made to Your Airtime Service Provider for the BlackBerry Prosumer Services. Please contact Your Airtime Service Provider for support, as RIM does not provide support directly to end users.
- **3.** <u>Unauthorized Use.</u> You must immediately notify RIM of any unauthorized use of Your BlackBerry Prosumer Services. You also agree that You will not disrupt the functioning of the BlackBerry Prosumer Services, solicit another end user's password, or otherwise act in a way that interferes with other end users' use of the BlackBerry Prosumer Services.
- **Restrictions on Use/Changes to BlackBerry Prosumer Services.** You agree that RIM may, without liability to You, establish and/or make modifications to limits on Your use of BlackBerry Prosumer Services and may make changes to the BlackBerry Prosumer Services including changes that materially limit or degrade any existing BlackBerry Prosumer Service functionality. If You lose Your Handheld Product or it is stolen, or if You transfer Your Handheld Product to a third party (as permitted by the BBSLA and Your Agreement with Your Airtime Service Provider), You must go to the BlackBerry Prosumer Services website and immediately disassociate Your email address(es) from that Handheld Product.
- 6. Requirement to backup/wipe Data. Except to the extent specifically prohibited by applicable law, RIM has no liability for any data transmitted to Your Handheld Product. You acknowledge and agree that the BlackBerry Prosumer Services enable You to access third party content, third party websites, third party software and third party services, including without limitation any third party email services which you access using the BlackBerry Prosumer Services. As further detailed in the BBSLA, You acknowledge and agree RIM has no responsibility for any third party content, third party websites, third party software or third party services that You access or acquire through Your use of the BlackBerry Prosumer Services, and that You are responsible for any contracts You enter into on the Internet. Care should always be taken when disclosing personal information about Yourself or others with third parties you interact with when using the BlackBerry Prosumer Services.
- 10. <u>Consent to Collection of Personal Information.</u> In addition to the provisions pertaining to the collection of personal information in the BBSLA, You authorize RIM to collect, use and store Your personal information relating to third party email services for so long as RIM deems necessary (but not longer than as permitted by applicable law), including, without limitation, Your user ID and password for each of Your third party email service account(s), and to disclose the same to the applicable third party email service providers for activation, billing, provision, maintenance and deactivation purposes.
- 11. <u>Conflict.</u> If any of the terms and conditions of this Addendum conflict with the terms and conditions of the BBSLA or with any other addendum or amendment to the BBSLA, these terms and conditions shall govern to the extent of the inconsistency, but only as it applies to the BlackBerry Prosumer Services.
