Viigo (TM) Mobile Client License Agreement

In order to access services and content provided by or using the platform technology of Viigo, Inc. ("Viigo") on a BlackBerry(R) handheld device, you must download and install the Viigo Mobile Client. The Viigo Mobile Client together with any updates later provided to you is referred to as the "Software".

The Software is licensed (and not sold) by Viigo, either to you individually (if you are agreeing to it in your own capacity), or if you are authorized to acquire the Software on behalf of your company or another organization, to the entity for whose benefit you act (in either case, "You"). To avoid You having to make Yourself familiar with yet another software license agreement, except for the modifications and additions set out in this document, the Software is licensed to You by Viigo under the terms and conditions set out in the BlackBerry Software License Agreement under which Research In Motion Limited (RIM) licensed the BlackBerry Handheld Software to You, as if the Software constituted BlackBerry Handheld Software that was pre-installed on your Handheld Product, the Software and associated Viigo Content and Services (as defined below) constituted Your BlackBerry Solution, and Viigo were RIM. The BlackBerry Software License Agreement as modified and appended by this document shall constitute the "Terms" on which the Software is licensed to You.

- 1. You may use the Software only in connection with the receipt and viewing of content received from, and/or accessing services provided by Viigo and suppliers of Viigo; and for the receipt and viewing of content received from content providers whose RSS, XML and/or OPML feeds (including Your own feeds) that You subscribe to receive and view using the Software. Content and services provided to you by Viigo are "Viigo Content and Services" and content and services provided by any other party (including Yourself and suppliers of Viigo) constitute Third Party Content and Third Party Services under the BlackBerry Software License Agreement.
- 2. You acknowledge that the use of this Software, the (including, without limitation, the advertisements provide for under Section 3 below) entails the transmission of data and that data transmission charges may apply. As between Viigo and You, You agree that You shall be solely responsible for all airtime and other data charges incurred in connection with the use of the Software.
- 3. You acknowledge that Viigo is only able to make the Software, and the Viigo Content and Services and Third Party Content and Third Party Services provided by Viigo's suppliers (collectively "Licensed Content and Services" that are accessible using the Software available to You free of charge in consideration of fees received by Viigo from third parties for advertising displayed via the Software in connection with the Licensed Content and Services. Accordingly, You agree to receive, facilitate (and for greater certainty, will enable when asked any connections required to serve such advertising to You) the distribution to You of advertising made available to You in connection with the Software (including in the Licensed Content and Services made available through the Software).
- 4. Viigo will have the right, exercisable in its sole discretion, to restrict or deny Your access to all or any portion of any content or any service made available via the Software.
- 5. The Software is provided by Viigo and its content providers and/or service providers on an "AS IS" basis without any liability to Viigo, its content providers and/or service providers and without any warranties of any kind, whether express or implied. Viigo may from time to time provide email support for issues You experience when using the Software and an 800 number that You may call to log any issues You experience with the Software, provided that You acknowledge and agree that Viigo has no obligation under this Agreement to furnish You with such support and may terminate provision of such support at any time in Viigo's sole discretion without notice to You.
- 6. The Software is subject to the United States Export Administration Regulations (EAR). In addition to the export obligations set forth in the BlackBerry Software License Agreement, You agree You will not export the Software to EAR's Group E countries and those countries subject to the U.S. Department of Treasury's Office of Foreign Asset Control or to parties on the United States Department of Commerce Bureau of

Industry and Security's Denied Persons List and Entity List and parties on United States Department of Treasury Office of Foreign Assets Control's Specially Designated Nationals List.

- 7. You hereby agree that Viigo shall own all feedback, comments, suggestions, ideas, concepts and changes that You provide to Viigo regarding the Software and all associated intellectual property rights (collectively the "Feedback") and you hereby assign to Viigo all of Your right, title and interest thereto. You will not knowingly provide Viigo any Feedback that is subject to third party intellectual property rights. You agree to cooperate fully with Viigo with respect to signing further documents and doing such other acts as are reasonably requested by Viigo to confirm that Viigo owns the Feedback and to enable Viigo to register and/or protect any associated intellectual property rights and/or confidential information.
- 8. In order to customize the content and services available through the Software, you are required to sign-up for a user account with Viigo. You will not disclose your user account credentials with any third party and you agree that you are solely responsible for all activities performed with your user account.
- 9. In addition to the provisions pertaining to the collection of personal information in the BlackBerry Software License Agreement, Viigo will collect, use and disclose Your personal information in accordance with its Privacy Statement available at [Link to full Privacy Statement] and Your personal information and content collected through the Software may be stored in the United States of America or Canada by Viigo or third party service providers retained by Viigo, and you consent to the collection, use, processing, transmission, and/or disclosure of such information by Viigo and/or its affiliated companies located inside or outside your jurisdiction. If you are a resident of the European Economic Area, your personal information may be transferred outside of the European Economic Area for processing on Viigo's behalf or to facilitate the use or functioning of Viigo products, services and/or websites.
- 10. Viigo will have the right, exercisable at any time in its sole discretion, to terminate these Terms (and the licenses granted to You hereunder) for any reason and without notice to You, however, if feasible, Viigo will use commercially reasonable efforts to provide You with notice of termination.
